Overtime: All time worked before and after the established work day of 8 hours, Monday thru Friday, shall be

paid at the rate of time and one-half. All work commencing with the beginning of the established work day on Saturday shall be paid at the rate of time and one-half. All work commencing with the beginning of the established work day on Sundays and/or holidays shall be paid at the rate of double time.

Holidays: New Year's Day, Memorial Day, Fourth of July, Labor Day, Veteran's Day (Nov. 11th),

Thanksgiving Day, day after Thanksgiving and Christmas Day. If a holiday fall on a Sunday, the

following Monday shall be observed.

Reporting Pay: Craftsmen reporting for work shall receive and (1) hour pay if work is not started by the normal starting time.

When employees are placed to work and begin work, they shall receive a minimum of four (4) hours pay, except in case of adverse weather conditions, in which case the employee shall receive pay for actual time worked, but not less than two (2) hours pay. If employee is asked to stay after the normal starting time, he shall receive two (2) hours pay. If employee starts to work in inclement weather, he shall receive

four (4) hours pay.
